



# U.S. Department of Defense Mentor-Protégé Program

We assist small businesses in successfully competing for prime contract and subcontract awards by partnering with large companies.

The DoD Mentor-Protégé Program\* strengthens and modernizes the defense industrial base by connecting businesses new to government contracting with more experienced government contractors to provide broader and deeper capabilities to the military supply chain.

## OBJECTIVES



Help eligible businesses expand their footprint in the defense industrial base to meet national security priorities while enhancing competition and cost savings for the government.



Increase the capabilities of small businesses to perform on DoD contracts.



Facilitate and enhance long-term business relationships.



Increase and strengthen the defense industrial base.

## TYPES OF AGREEMENTS

Mentor-Protégé Agreements focus on areas of developmental assistance, which can include technology transfer and technical enhancement, cybersecurity readiness, and business infrastructure.

- Reimbursable: Up to \$1M per year for 3 years
- Credit: Small business subcontracting credit to the mentor
- Hybrid: Subcontracting credit for 1 year and reimbursement for an additional 2 years

## WHO CAN PARTICIPATE



### MENTORS

- Currently performing under an active approved subcontracting plan
- Eligible for Federal contracts



### PROTÉGÉS

- Cannot be owned or managed by individuals or entities that directly or indirectly have stock options or convertible securities in the mentor firm
- Must meet additional statutory requirements outlined in [10 USC 4902](#)

\*Established November 5, 1990 (Public Law 101-510) and made permanent in the 2023 National Defense Authorization Act (10 USC 4902).

## HOW TO PARTICIPATE

1

### Establish a Counterpart:

Mentors and Protégés are responsible for finding each other.

2

### Determine Agreement Type:

Reimbursable, Credit, or Hybrid.

3

### Develop the Agreement:

Align developmental assistance with the protégé's strategic vision.

4

### Submit Agreement Proposal:

Contact the agency's small business office for submission details.

5

### Start the Agreement:

Credit agreements start on approval; reimbursed agreements start when funds are obligated.

6

**Follow Reporting and Defense Contract Management Agency (DCMA) Review and Reporting Requirements:** These impact the mentor's reimbursement eligibility in the remaining years of direct reimbursement agreements.
