SBIR Policy Directive Data Rights

- 8(b) Rights in Data Developed Under SBIR Funding Agreement.
 - (I) Each agency must refrain from disclosing SBIR technical data to outside the Government (except reviewers) and especially to competitors of the SBC, or from using the information to produce future technical procurement specifications that could harm the SBC that discovered and developed the innovation.



SBIR Data Rights vs Patent Protection

SBIR Data Rights Advantages

- 1. Immediate
- 2. Longer lasting 35 years and counting
- 3. Low cost
- 4. No lawyers needed
- 5. SBA will help defend
- 6. Requirement that violations be reported to Congress

Key requirements:

- 1. Include SBIR DATA rights legend in submission
- 2. Keep secret, no disclosure. Patents applications are disclosure in 18 months.
- 3. Publication defeats SBIR data rights?
